Thanks for checking in on this – we expect to continue to bring in victims and witnesses in connection with the active grand jury proceedings, under the same USAO number as before ([REDACTED]). Some individuals will be subject to grand jury subpoenas, and others may be meeting with us in lieu of testifying before the grand jury. We can advise if we believe we need to use USAO funds, or if other issues arise, but we can confirm we do still have an active grand jury investigation (including prospective grand jury testimony).
