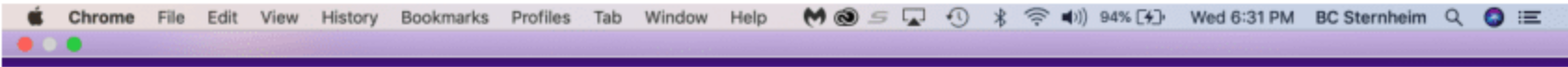
Good evening-
